COOKIE POLICY - INFORMATION ON THE PROCESSING OF PERSONAL DATA OF WEBSITE USERS CARRIED OUT THROUGH THE USE OF COOKIES AND OTHER TRACKING DEVICES

New Europe Srl (hereinafter also "MADE"), as the data controller of personal data, intends to provide, pursuant to and for the purposes of Article 13 of Regulation (EU) 2016/679 – General Data Protection Regulation (hereinafter "GDPR"), certain specific information regarding the processing of personal data related to the user ("User" or "Data Subject") carried out through cookies and other tracking devices installed or used on this website (hereinafter "Website"), in addition to the information provided to the User within the Web Site Privacy Policy of MADE eventi S.r.l.

It should be noted that this privacy notice is provided only for the Site and not for other websites that the User may access through links (for which reference should be made to the respective privacy notices/policies).

#### WHAT ARE COOKIES

Cookies are short strings of text that websites visited send to the User's browser (that is, the program used for browsing, such as Chrome, Mozilla, Firefox, Safari, Explorer), where they are stored to be later retransmitted to the same websites during subsequent visits.

During browsing, the User may also receive cookies on their browser sent by entities other than the owner of the visited website (so-called 'third-party' cookies).
